## All contact lens examinations include the following, as needed:

- History and comprehensive exam of the eyes
- Measurements to determine contact lenses
- One pair of diagnostics/trial contact lenses
- Sample of contact lens multipurpose solution
- All necessary follow-up visits to complete the prescription process, within a 60 day time limit from the date of the initial exam.
- Training on insertion & removal of contact lenses for new contact lens wearers
- Instruction of the proper care of contact lenses

A contact lens prescription is valid for **one year** from the date of the initial examination. No contact lenses will be ordered unless an exception has been made by the prescribing doctor.

Once a prescription has been finalized, you may purchase your contact lenses with us. They will be shipped directly to your home or office and typically take 5-7 business days. Expedited service is available at an additional cost of \$25.00.

#### Fees are as follow:

Annual fit and Contact Lens Evaluation Fees: \$50-\$300 depending on the type of lens

Custom fit fees will be dependent on the complexity. Fees range from \$400-\$900

According to the Fairness to Contact Lens Consumers Act, which went into effect February 4, 2004, we are providing you with our Contact Lens Evaluation Fees. You will be given a copy of your contact lens prescription once finalized and is valid for 1 year.

### **Contact Lens Evaluation Fees**

| \$100 | Update prescription, same contact lens                         |

| \$200 | Change in brand of contact lenses                              |
| \$200 | Change because of poor fit, dry eye or poor vision             |
| \$300 | New Fit for Astigmatism  |
| \$300 | New fit soft contact lenses switching from Rigid Gas Permeable |
| \$350 | New fit Monovision (one eye for distance, one eye for near)    |
| \$400 | New fit Multifocal   |
| \$400 | New fit Rigid Gas Permeable                                    |

Your evaluation/ fitting fee covers your trial lenses and up to 2 months of follow-up care. Follow-up care is vital to determine the fit of the lens and to protect the health of your eye. If you elect to forego the follow-up care and return beyond the initial 2 month period, normal office visit fees will apply. We do urge you to protect your vision and return for the follow-up care. Trial lenses are not for permanent use. You must have follow-up care to be able to purchase contact lenses. The prices of contact lenses will vary depending on the type of contacts that your doctor recommends and your prescription.

### The Evaluation/Fitting fee is not refundable or credited.
